- ❖ Approval of the minutes of the November 17, 2020 regular meeting and Public Hearings: Ms. Cultice made a motion to approve minutes as written, seconded by Mr. Woolery. Motion carried (7-0)

 - Vice President
 - Ms. Cultice made a motion to reappoint Mr. Bill Crase as vice president, seconded by Mr. Jackson. With no other nominations, motion carried (7-0)
 - Administrator/Building Commissioner
 - Mr. Chaffins stated that as we all know we have had a little bit of a problem, back in the summer we wanted to separate the administrator and the building commissioner and make Pam the administrator, that never made it past the commissioners so now we will need to advertise for a building commissioner, because we appoint them, he stated that it should be a two week notice, not sure, and not appoint anyone to the building commissioner position tonight. Also would like to make Pam the administrator/clerk.
