IN RE: February 16, 2009 MINUTES

Chuck Estok moved to approve the minutes of the February 16, 2009, meeting seconded by Bill Dulin with 5 ayes.

IN RE: ADDITIONAL APPROPRIATION ORDINANCE #2009-02

Bob Smith, IT Coordinator requested \$1084.00 out of Cum. Cap. for two new computers for the treasurer's office, \$4102.00 for a new server for the Jail and Courthouse, and \$3520.00 for an air conditioning unit for the IT office in order to keep the servers cool. Bill Dulin moved to approve the \$8706.00 request seconded by Chuck Estok with 5 ayes.

Sheriff Oscar Cowen requested \$55,000 for two squad cars. Chuck Estok moved to approve \$27,500 for one squad car seconded by Judy Benninghoff with 5 ayes.

The highway department requested \$72,824 for stone gravel and aggregates, \$16,380 for bituminous and \$1,700 for road signs totaling \$90,904. This is in order to appropriate the F.E.M.A. reimbursement we received. Bruce Fingerhut moved to approve the \$90,904 seconded by Bill Dulin with 5 ayes.

IN RE: TRANSFER ORDINANCE #2009-03

The highway department requested a transfer of \$6,000.00 from liability insurance to unemployment. Bruce Fingerhut moved to approve seconded by Chuck Estok with 4 ayes 1 nay (JB).

IN RE: KNOX REDEVELOPMENT COMMISSION

Bill Dulin moved to appoint Julie Berndt to the Knox Redevelopment Commission as their council appointment seconded by Chuck Estok with 5 ayes.

IN RE: REASSESSMENT

Rhonda Milner, County Assessor, reported that the reassessment is scheduled to start July 1, 2009. She explained the process and the proposed legislation that may change the way reassessment is done. They are writing the contract with the stipulation that it may be cancelled or modified if legislation changes. She'll be taking proposals for contracts.

IN RE: SHERIFF'S RETIREMENT PLAN

Elaine Beatty with McCready & Keen to discuss the Sheriff's retirement plan. Also present were Harold Welter and Sheriff Oscar Cowen. She submitted a letter summarizing results of the study on the plan. \$286,375 is needed to bring the plan up to date through 12-31-09.
