Continuation of the public hearing to consider a use variance request by **MICHAEL THOMAS** to place a 1980 MH Type II on parcel with existing MH Type II in area zoned agricultural on property owned by **SHARON YOUNG & JENNIFER KING** and described as follows: Section: 15, Township: 32-3, PT: Oak Grove Trlr Sub #4, Lot 1 & 2 Block C Parcel: 014-0001-00, and located at 5326 S A Street North Judson, IN 46366.

 - Mr. Wallsmith replied that yes it will.
 - Chairman Bartoli also asked about the positioning of the building.
 - Mr. Wallsmith replied that it will be south of the house.
