- I) Pledge of Allegiance
- II) Roll Call: Roger Chaffins, president & citizen member; Bryan Cavender, vice president & councilman; Bill Crase, surveyor; Phil Woolery, extension educator; Byron Walters, trustee; Betty Dotlich, Jeff Fosler, and Denise Thomas, citizen members; Martin Bedrock, commission counsel; Terry R. Stephenson, administrator/building commissioner; and Pamla J. Starkey, clerk/secretary. There were (6) six visitors present.
- III) Approval of the minutes of the April 20, 2016 meeting
 - ◆ Mr. Fosler made a motion to approve minutes as written, seconded by Mrs. Dotlich. Motion carried (8-0)
- IV) Notice of Public Hearing: Pursuant to the laws of the State of Indiana contained in I.C.36-7-9, the Starke County Plan Commission hereby orders that the open storage of junk located at 8172 N. S.R. 23, Walkerton, IN. 46574, owned by Angela J. Fry, legal description: S2 T34 R1, Meadows, Pt lots 8 & 9, Block 1 & Resort Acres Pt Lot 4, State ID #75-03-02-404-046.000-009 must be removed and premises cleaned.
 - ♦ Mr. Chaffins opened the public hearing
 - Mr. Stephenson explained that the property is a mess again and we already had a public hearing on this property last May, Ms. Fry cleaned it up and fines were not implemented and now it is a mess again.
 - Mr. & Mrs. Noble were present and stated that they would like to see it cleaned up
 - Mr. Crase made a motion to close the public hearing, seconded by Mr. Woolery. Motion carried (8-0)
 - After discussion by the board, Mrs. Dotlich made a motion to consider this a chronic nuisance, two nuisances within a three year period, and implement the \$350.00 fine plus clean up costs and administrative fee of \$700.00 and Mr. Stephenson will need to contact the Starke County Sheriff's Department to clean up the property, seconded by Mr. Woolery. Motion carried (8-0)
- V) Notice of Public Hearing: Pursuant to the laws of the State of Indiana contained in I.C.36-7-9, the Starke County Plan Commission hereby orders that the Inoperable Vehicles and Junk located at 2620 W. Julia Dr., North Judson, IN. 46366, owned by Dustin Taulbee, legal description: S15 T32 R3, Oak Grove Trailer Sub #3, Lot 1 Block C, State ID #75-09-15-104-021.000-014, must be removed and premises cleaned.
 - Mr. Chaffins opened the public hearing
 - Mr. Taulbee was present and explained that the cars are not there for more than (30) thirty days. He also stated that he tried to explain his case last May and Mr. Estok wouldn't let him.
 - Mr. Stephenson stated that you are only allowed (1) one vehicle and only for (7) seven days.
 He also let the board know that his property is cleaned up now.
