

Starke County Planning Commission  
Regular Meeting  
June 20, 2012

Attendance: Butch Ritchie, president & citizen member; Denise Marks, executive secretary & citizen member; Daniel Bridegroom, commissioner; Judy Benninghoff, councilwoman; Dennis Estok, surveyor; Byron Walters; trustee; Richard Singleton, citizen member; Steven A. Dodge, commission counsel; Bruce W. Williams, administrator/building commissioner; and Pamla J. Starkey, clerk/secretary. There were two (2) visitors present.

1. Approval of the minutes of May 16, 2012 meeting: Mrs. Benninghoff made a motion to approve minutes as written, seconded by Mr. Walters. Motion carried (7-0)
2. New Business
  - a) 2012 Budget: After discussion by the board Mrs. Marks made a motion to approve the 2013 Budget as submitted with the addition of (500) five hundred dollars in the Fuel Lube and Tire line item for a total of (3,000) three thousand dollars, seconded by Mr. Walters. Motion carried (7-0)
  - b) Review Zoning Ordinance: Mr. Dodge went over the changes/corrections that need to be made on the Unsafe Building Ordinance, Contractor Ordinance, and the WECS Ordinance.
3. Tech Committee
  - a) Letter was sent to several attorney's asking if they would be interested in being the plan commission and board of zoning appeals counsel beginning 2013.
4. New & Old Violations
  - a) C & C Salvage court date is set for July 30, 2012
  - b) Vernon & Auglee Hammond/Ward Allen: property located at 1175 W. S.R. 10, North Judson. The property is now in Ward Allen's name and he did come in and applied for a permit to remodel.
  - c) Lynda & Anna Kolasa, 11440 E. S.R. 8 Culver: Went to court on June 4, 2012, property is to be brought into compliance by December 4, 2012 and pay the court costs.
  - d) Marcelo Godoy: Property is located on the east side of S.R. 23, north of 400 N. A mobile home was placed on the property without a permit in an R2 zoned area. Two letters were sent. After discussion by the board, Mr. Singleton made a motion for Mr. Dodge to write a letter with authority to sue, seconded by Mr. Walters. Motion carried. (7-0)
5. End of the month reports were distributed.

Mrs. Dotlich asked if Mr. Williams checked on the old school house, he stated that they did come in and get a permit and also paid the fines.

With no further business, Mr. Estok made a motion to adjourn the meeting, seconded by Mr. Walters. Motion carried.
