Pursuant to adjournment comes now the Starke County Board of Commissioners and meet in special session at 11:00AM in the Annex meeting room, Knox, Indiana, with Dan Bridegroom, Kathy Norem, and Jennifer Davis present and the following proceedings were held to wit:

President Dan Bridegroom called the meeting to order. The purpose of the meeting is the opening of bids for: The construction of the replacement of County Bridge 156, carrying Range Road over Robbins Ditch. The work includes pile driving, concrete work, beam placement, asphalt and guardrail work. County Attorney Marty Lucas opened the four bids that the Commissioners had received. Superintendent, advised the beams are already on order from the Debco Company and will be at a cost lower than their annual beam bid. He advised the beams are scheduled for delivery in mid September. Ken Minett, of Butler, Fairman, & Seufert advised the bridge should be open for traffic 82 days from today.

Commissioner Norem made a motion to take the bids under advisement, to recess the meeting to review the bids, with the intention of reconvening the meeting and awarding the bid today. Commissioner Davis seconded the motion, and it passed with all ayes.
