## **AUGUST 18, 2014**

Pursuant to adjournment comes now the Starke County Council and meet in a special session at 12:00PM in the Annex meeting room, Knox Indiana and the following proceedings were held to wit:

The meeting was called to order by Council President Dave Pearman. He advised the purpose of the meeting was to review the County Departments' 2015 budgets.

Absent from the meeting were Councilmen Bob Sims and Bryan Cavender. Also present for the budget review was Commissioner Kathy Norem.

The Board began with the review of the proposed County General Budget by department and continued with each Fund's proposed budget, in fund numerical order.

When the review by the Board was completed the total adjusted budget for each Fund was as follows:

County General: \$6,049,923.00 Cumulative Bridge: \$505,241.00

Cumulative Capital Development: \$106,000.00

Health: \$147,239.00

Local Health Maintenance: \$33,139.00 Local Road & Street: \$257,500.00 Highway Department: \$2,282,674.00

Reassessment: \$340,740.00

Pretrial Diversion Fund: \$113,232.00 LHMF/Tobacco Settlement: \$17,494.00

Supplemental Adult: \$74,368.00 Supplemental Juvenile: \$16,027.00

At the conclusion of the last fund budget review the Board advised Auditor Chaffins to go back through the budgets and incorporate a 2.7% payroll increase, which will also increase the proposed budgets of the FICA and PERF line items in several budgets. President Pearman noted the status of the pay increase will depend on the DLGF approval of the County's budgets.

(Following the meeting Auditor Chaffins made the authorized 2.7% increases to the payroll expenses thus adjusting the final totals for each budget.) The final budgets, per fund and per department are as follows:
