Starkey, recording secretary. There were (6) visitors present.
- II) Approval of the minutes of the July 17, 2013 meeting: Mrs. Cultice made a motion to approve the minutes as written, seconded by Mr. Chaffins. Motion carried (6-0)

Mrs. Cultice made a motion to move New Business, the preliminary hearing for Almero subdivision, before New & Old Violations, seconded by Mr. White. Motion carried (6-0)

### III) New Business

- Preliminary Hearing for a subdivision named Almero, consisting of (10) ten lots in section 6 of North Bend Township. Property owners being, Robert & Madalyn Michels
  - Mr. Cramer with Progressive Engineering was present to discuss the plans.
  - Mr. Cramer stated that he already contacted the Bass Lake Sewer District they will need to install new sewers
  - They will not have access to Boa Shores Park
  - Mr. Cramer stated that they will be ready for a public hearing next month.
  - After discussion, Mr. White made a motion to set the Almero Subdivision for a public hearing next month, seconded by Mrs. Cultice. Motion carried (6-0)

  - Mr. Stephenson stated that he went to the property but could not see anything because of the foliage.
  - Mr. Rushing made a motion to table this violation until fall or is able to see the violation more clearly, seconded by Mr. White. Motion carried (6-0)
- ♦ William Allen etal, property is located on the NE corner of Holstine St. & Range Rd.
  - Mr. Stephenson let the board know that the cleanup is almost completed.
- ♦ Harold Awald & Bonnie Case, 10425 E. 400 N. Grovertown
  - Mr. Awald called and stated that he is working on the removal of vehicles and cleaning the property.
- ♦ Dennis Guard, 7835 N. Tecumseh Rd. Walkerton
  - Mr. Stephenson stated that he looked at the property and agrees with Mr. Williams findings on 12/6/2011 that the building is structurally sound and we do not have an ordinance on grass height.

  - Mr. Bedrock stated that he sent a letter to Mr. David Geisler
  - Mrs. Dotlich stated that it is listed for sale with Caldwell Banker
- ♦ Lynda & Anna Kolasa, 11475 E. S.R. 8, Culver
  - Mr. Stephenson stated that the mortgage company, Wells Fargo, called and would like to remove the barn and remodel the dwelling.
  - Mr. Stephenson suggested that he make an appointment with the mortgage company to look at the dwelling to make sure they still want to remodel, the board agreed.
- Mr. Armstead asked about the property located on 1100 E. north of Old 30 on the west side of the road. He stated that there are two trailers on the property and the property is still a mess.
  - Mrs. Dotlich stated that would be Keith Gerrard's property
  - Mr. Stephenson stated that he viewed the property from the road and it didn't look bad and didn't see the trailers but will check again.

- Mr. White made a motion to set the Fee Schedule for a public hearing next month, Mr. Rushing would like more information before setting a public hearing, other board members agree, motion dies due to the lack of a second.

- ♦ Review of Nonconforming Use Ordinance
  - Mr. Bedrock stated that he thinks there is to much language in the descriptions
  - Mr. Chaffins made a motion to set the Nonconforming Use Ordinance for public hearing next month, seconded by Mrs. Dotlich. Motion carried (6-0)
