- Chairman Bartoli read the request listed above
- All notifications were not in order
- The notification for Raena Beem did not come back.
- Chairman Bartoli explained the options.
- The applicant chose to proceed.
- Attorney Dodge explained why the applicant was before the board.
 - They want to dispute the decision made by the zoning administrator regarding.
- Applicant Bernadeta Siek and property owner Wojciech Siek were present.
- Applicant Siek explained her intent.
 - She stated that they eventually plan to build a house on the property.
 - They bought a mobile home to stay in during visits temporarily, until the house is done. She stated it would be approximately a year.
 - They purchased the mobile home than never received the title from the man that sold it to them.

 - Asked how long the applicant has been on the property.
 - o The applicant replied since 2007.
 - Asked if the property is for sale right now.
 - o The applicant replied that it is for sale by owner.
 - Asked how long the trailer has been there.
 - o The applicant replied that it has been there since August.
 - Noted that there are a lot of tall weeds around it.
 - Asked if it the trailer is 12x53.
 - o The applicant replied that yes it is.
 - Asked if it was a construction office.
 - o The applicant replied yes.
 - Asked if it has a bathroom.
 - o The applicant replied yes.
 - Asked if it is divided off into rooms.
 - o The applicant replied yes.
 - Noted that the trailer is in rough shape.
- Chairman Bartoli:
 - Asked if this was the only trailer available for the applicant to purchase at the time.
 - o Mr. Siek replied that he liked this one because it is big. Also that he doesn't want to spend too much money on a trailer since they plan to build a house next year.
 - Asked how much they paid for the trailer.
 - o The applicant replied \$800.
 - Noted that the trailer is not titled nor does it have a data plate so there is now way of knowing if it is up to code for this area.
- Attorney Dodge stated all the issues with the trailer besides there being no title and it being undersized.
