IN RE: ADDITIONAL APPROPRIATION ORDINANCE #2007-24

Mark Smith moved to approve the Recorder's request for \$3,000 out of the REDACT fund, seconded by Dan Awald with five ayes (Jennifer Davis had not arrived yet.)

Douglas J Vessely moved to approve the Coroner's request for \$500 for equipment, with a reduction of \$250 in both morgue rental and transportation to move bodies. Mark Smith seconded this request and it passed with six ayes.

Mark Smith moved to approve the Highway's request for \$16,590 for gas and oil, seconded by Charles Estok, with six ayes.
