BOARD OF COMMISSIONERS OF STARKE COUNTY, INDIANA

RESOLUTION NO. 2019-06

WHEREAS, IC 36-7-25-4 authorizes Starke County ("County") and the Knox Redevelopment Commission ("City Redevelopment Commission") to jointly undertake economic development projects in contiguous areas within each unit's jurisdiction;

WHEREAS, the City Redevelopment Commission did on July 30, 1997, adopt a declaratory resolution, as amended on December 13, 2004, and as further amended and restated on October 30, 2015, and as confirmed on December 3, 1997 by a confirmatory resolution, as amended on November 23, 2015, establishing and enlarging the Knox Redevelopment Area ("Original Area") as a blighted area under IC 36-7-14 and IC 36-7-25 (collectively, "Act");

WHEREAS, the City Redevelopment Commission now desires to expand the Original Area ("Proposed Expansion"); and

WHEREAS, a portion of the Proposed Expansion is within the jurisdiction of the Starke County Redevelopment Commission ("County Commission") and is contiguous with the Original Area and located within the jurisdiction of the County Commission, with such parcels listed on the attached Exhibit A ("County Area");

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF STARKE COUNTY, INDIANA;

Section 1. The Board of Commissioners hereby assigns the jurisdiction of the County Area to the City Redevelopment Commission for the purposes set forth in the Act.

Section 2. The City Redevelopment Commission may take all action in the County Area that could be taken by a redevelopment commission in an allocation area in the manner and to the extent provided for in the Act.

Section 3. This resolution shall be effective upon passage.
