

STARKE COUNTY COUNCIL ORDINANCE 2021- 010
USE OF RECORDER'S RECORDS PERPETUATION FUND
DURING CALENDAR YEAR 2022

WHEREAS MANDY THOMASON, Recorder of Starke County (the "Recorder") has requested that the sum of \$500.00 of the Recorder's Records Perpetuation Fund be used to pay for postage expenses of the Recorder's office for calendar year 2022 pursuant to authority and conditions of Ind. Code § 36-2-7-10.2(b); and,

THE RECORDER has filed an affidavit in support as required by said statute, which affidavit is attached hereto as Exhibit A; and,

WHEREAS the Council finds that the Recorder's affidavit is in proper form and complies with the statute and finds that the Recorder's request should be and hereby is approved and adopted.

NOW, THEREFORE, BE IT ORDAINED by the Starke County Council that:






