IN RE: MINUTES

IN RE: PAYROLL

Mark Milo moved to approve the payroll seconded by Dan Bridegroom with 3 ayes.

IN RE: DISTRICT PLANNING COMMISSION

Kathy Norem moved to appoint Dave Pearman from Washington Twp. to the District Planning Commission seconded by Mark Milo with 3 ayes.

IN RE: HIGHWAY

Bridge #156 on Range Road is a historical bridge and needs to be the starting point for bridge repairs and replacements. It is possible that it could be on the "untouchable" historic bridges list. We will find out for sure at road school.

A situation arose at the highway regarding someone being released for return to work, but he is on oxygen. The D.O.T. suggested that they have a D.O.T. doctor check him out.

The surveyor had an additional in front of the council for a new vehicle or repairs on the old one which was withdrawn because the commissioners offered to replace his vehicle with one from the highway in order to save the county money. Mark Milo moved to approve the surveyor switching vehicles with the highway garage seconded by Kathy Norem with 3 ayes.

Sue Himes, highway clerk, reported that we are seven bridges behind on our bridge schedule going into 2009.

Jeff Larrison stated that a draft of the bridge inspection should be back by the next meeting.
