The meeting was called to order by Council President, Dave Pearman at 5:30PM.

AUDITOR BUSINESS

Councilman Hazelton made a motion to approve the minutes from the January 19, 2021 meeting. Councilwoman Gudeman seconded the motion and the motion was approved with all ayes.

ADDITIONAL APPROPRIATION SHERIFF
