- I) Pledge of Allegiance
- II) Roll Call: Dennis Estok, president & surveyor; Roger Chaffins, vice president & trustee; Bryan Cavender, councilman; Chad Rushing, extension educator; Betty Dotlich, Jeff Fosler, and Denise Thomas, citizen members; Martin Bedrock, commission counsel; Terry R. Stephenson, administrator/building commissioner; and Pamla J. Starkey, clerk/secretary. There were (5) five visitors present.
- III) Approval of the minutes of the January 15, 2014 meeting and public hearing:
 - Mr. Rushing pointed out that in item 5, first bullet third line, the word get should be between the words could and everything.
 - Mr. Chaffins made a motion to approve minutes with the amendment mentioned, seconded by Mr. Rushing. Motion carried (7-0)
- IV) Public Hearing to consider the approval of an amendment to the Code of the County of Starke, Indiana dated 1991, 6-12-3-2-2(H) Manufactured Housing Ordinance by removing section 6-12-3-2-3(H)(3):
 - Mr. Estok opened the public hearing

 - Mr. Rushing stated that if we make it more difficult for the people they might be more apt to move them in illegally.
 - After discussion, Mr. Cavender seconded the motion. Motion carried (5-2) Dotlich and Thomas against.

 - Mrs. Dotlich stated that they do not have current permits.
