MINUTES MARCH 19, 2009

Chairman Nagai opened the meeting at 6: 30 p.m.

I. Pledge of Allegiance was lead by member Bartoli

II. ROLL CALL – Lee Nagai-Chairman, Jack Hudgens-Vice Chairman, Sheri Bartoli-Member, Don White-Member, Roger Chaffins-Member, Steve Dodge-Attorney (Absent), Bruce Williams-Planning Commission Administrator (Absent) and Emily N. Ferch-BZA Recording Secretary (Absent) Pamla Starkey – Planning Commission Recording Secretary

III. Review of the meeting minutes for February 19, 2009 – Member Bartoli suggested that a specification be made in section V, to itemize/identify the 2 items that were non-verbally requested from the applicants by Zoning Administrator Bruce Williams. Member Chaffins motioned to table the meeting minutes, until the 2 items are identified, seconded by member White. Motion carried 5-0.

IV. Continuation of the Public hearing to consider request for a variance by **ALLEN & PAMELA BALCHUNAS** to place a mobile home type II in area zoned R-2 on property owned by **JAMES & CHARLOTTE TOLSON**, and described as follows: Section: 35, Township: 32-1, Parcel: 007-02299-00, Johnsons Addition Block: Y Lots 81-85, Residential vacant platted lot located in Monterey, IN 46960.

- Chairman Nagai read the ordinance listed above
- Mrs. Starkey updated the board concerning this request
 - This matter had been tabled for 30 days per applicant request, due to unmet notice requirements
 - All green cards have been returned to the office, except for 2 that have been returned to the sender
 - No information (title or data plate) has been provided to the zoning administrator from the applicant

- Victor Carnegie was neither for or against this request, but had questions concerning property value and flooding issues
