## JULY 25, 2019

Pursuant to adjournment comes now the Starke County Council and meet in a special session at 10:00AM in the Annex meeting room, Knox Indiana and the following proceedings were held to wit:

The meeting was called to order by Council President Dave Pearman at 10:00AM. He advised the purpose of the meeting was to review the County Departments' 2020 budgets.

Council Members present for the meeting were Dave Pearman, Brad Hazelton, Freddie Baker, Kay Gudeman, and Don White. Absent from the meeting was Councilman Robert Sims and Councilman Howard Bailey.

## **COUNTY GENERAL FUND 1000:**

The County General Fund requested budgets were reviewed by department.

0001 Clerk: Councilman Hazelton made a motion to approve the Clerks proposed budget of \$196,064.00. Councilman Baker seconded the motion and it passed with all ayes.

0002 Auditor: Councilman Hazelton made a motion to approve the Auditors proposed budget of \$183,034.00. Councilman Baker seconded the motion and it passed with all ayes.

0003 Treasurer: Councilman Hazelton made a motion to approve the Treasurers budget in the amount of \$101,040.00, this includes a cut of \$3,500.00. Councilman Baker seconded the motion and it passed with all ayes.

0004 Recorder: Councilman Hazelton made a motion to approve the Recorders proposed budget of \$78,860.00. Councilman Baker seconded the motion and it passed with all ayes.

0005 Sheriff: Councilman Hazelton made a motion to approve the proposed budget of \$709,149.00. Councilman Baker seconded the motion and it passed with all ayes.

0006 Surveyor: Councilman Hazelton made a motion to approve the Surveyors proposed budget of \$79,977.00. Councilman Baker seconded the motion and it passed with all ayes.

The approved budget is \$119,798.00. 0023 Drainage Board: The approved budget is \$11,100.00. 0024 Veteran Service Officer: The approve budget is \$16,289.00.

0025 Commissioners: Councilman Hazelton made a motion to approve the Commissioners' budget in the total amount of \$2,511,534.00. Councilman Baker seconded the motion and it passed with all ayes.

0026 Courthouse: Councilman Hazelton made a motion to approve the budget in full of the Courthouse for a total amount of \$81,868.00. Councilman Baker seconded the motion and it passed with all ayes.

0027 Jail: Councilman Hazelton made a motion to approve the jail budget in the amount of \$178,395.00. Councilman Baker seconded the motion and it passed with all ayes.

0028 Annex Building: Councilman Hazelton made a motion to approve the budgets in full of the Annex Building, Circuit Court, BZA, Soil & Water, Prosecutor and County Council. Councilman Baker seconded the motion and it passed with all ayes.

The approved budget total for the Annex Building was \$75,480.00.

0029 Circuit Court: The approved budget of Circuit Court was \$517,299.00.

0030 BZA: The approved budget of the BZA was \$19,938.00.

0031 Soil & Water: The approved budget of Soil & Water was \$34,412.00.

0032 Prosecutor: The approved budget of the Prosecutor was \$117,159.00.

0033 County Council: The approved budget of the County Council was \$37,128.00.

0035 IT: Councilwoman Gudeman made a motion to approve the IT budget in the amount of \$318,136.00 contingent upon Auditor Oesterreich looking into the proposed LLOW contract fees and the Board of Commissioners approval of ICloud Storage. Councilman Baker seconded the motion and the motion passed with all ayes.
