- IV) Public Hearing: Pursuant to the laws of the State of Indiana contained in I.C.36-7-9, the Starke County Planning Commission Administrator hereby Orders that the unsafe structure located on the NE corner of U.S. 421 and Ann Street in San Pierre, In. 46374, S21 T32 R4, Brazills 1<sup>st</sup> Lot 1, State ID #75-08-21-303-045.000-011 be removed and premises cleaned up. Property Owners Being: Timothy & Christine Yokovich.
- V) ALSO Public Hearing: Pursuant to the laws of the State of Indiana contained in I.C.36-7-9, the Starke County Planning Commission Administrator hereby Orders that the unsafe structure located at 10020 W. 550 S. San Pierre, IN. 46374, S17 T32 R4, Pt NE W of RR 2.766 Acres, State ID #75-08-17-200-010.000-011, be removed and premises cleaned up. Owners being Timothy & Christine Yokovich.
  - Mr. Chaffins opened the public hearing
  - Mr. Wallsmith & Mr. Yokovich were present regarding the public hearing
    - Mr. Wallsmith explained that Mr. Yokovich has been ill but is now well and plans to repair both buildings on the two properties with applying for the proper building permits and in an allotted time.
    - Mr. Bedrock explained to Mr. Wallsmith that Mr. Yokovich has been notified several times regarding these properties, and that Mr. Stephenson has been very considerate and given many opportunities to repair the structures.
    - Mr. Yokovich explained that he had several health problems to keep him from working on them. He also explained that the building has been struck by a couple of vehicles at different times.
    - Mr. Chaffins doesn't feel that anything will ever get done, no matter how much time he is given, as we have been dealing with this since 2009.
    - Mr. Chaffins asked how much time he needs, Mr. Yokovich stated that he would like (90) ninety days for the one uptown and (6) six months on the property on 550 S.
    - Mr. Crase stated that we will be getting winter weather soon and asked if he will get it done within the 90 days with the time starting tomorrow.
