WINTER OPERATIONS

Our winter operations are essentially over. Because of the relatively mild winter we used 25% less sand and 50% less salt this year compared to last year. Our salt dome is full. This means we have a sizeable reserve for next year. We have stored all our winter equipment and have refitted all our trucks for summer operations.

SPRING/SUMMER OPERATIONS

- 1) **Culvert replacements** – We have replaced and/or repaired ten culverts in the last month. We have two more to complete in our first round of replacements (highlighted in yellow). We will then replace culverts on an as needed basis throughout the summer and then begin round two of the planned replacements in the fall after our paving operations are complete. We anticipate replacing about thirty pipes this year. Those highlighted in green are those we did in coordination with the Surveyor to help him with some of his projects. We will also be allowing him to store some material at the garage and use some of our used, salvaged pipes. He will also be purchasing his material through our departments negotiated price arrangements with vendors

- 2) **Brush Cutting** – Our chopper mower has been running for much of March. We are hiring our summer mowers and they should be starting some time later this month
- 3) **Potholes and other frost repairs** – We have patched throughout March
- 4) **Sand and Gravel stockpiling** – We have stockpiled nearly all our summer operations material
- 5) **Oil bids for asphalt** – Have been sent out and the one we have received is significantly lower than last year (15% lower)
- 6) **Road Assessments and repair selection** – PASER ratings are complete, we are now combining all of our lists (PASER, needs list, citizens concerns, driver picks, etc.
- 7) **Mowing Crew (Double Mowing)**

- 8) **Bridge maintenance crew** – Will begin their operations this week. As per our bidget we will be purchasing a bridge maintenance truck. This will complete our department's needs for pickups for the next two year, barring unforeseen circumstances.
- 9) **Bridge replacement** The construction of Bridge #1 (700N between US35 and 500E) is going well and should be complete by early May. The design for bridge #78 (250W between is nearly complete we should be bidding it out next month. Bridge #96 will be replaced by a culvert later this summer. After these replacements are complete we will have only eight deficient bridges in the County, one ahead of our Bridge Asset Management Plan schedule.
