SPRING ROADWAY MAINTENANCE -

Patching was done throughout July and will continue into August.

We removed over 62 trees from roadways in June (45) and July (17)

We replaced or repaired 4 culverts in July

Today we used our "new" distributor truck for the first time. We chip sealed the garage parking lot. We will be using it to chip seal about 18 miles of roadway over the next two months.

We Also used our "new" water truck for the first time for dust control.

<u>MOWING</u> – Our mowers were active as much as possible in July. The weather has improved and we have managed to mow over 3200 miles in July. We still have much brush to cut back from the roadway due to the rain over the last two months.

BRIDGE

LOCAL BRIDGE REPLACEMENTS AND REPAIRS:

Bridge #1 on CR700N over the Robbins ditch, .3 miles W of CR500E is currently being designed. Construction should begin late this summer

Bridge #71 CR100E over Smith Ditch, .5 m S of CR500S – is currently being designed. Construction should begin early next Spring

Bridge #96 on 900S, .5 miles W of US421 – We will be removing this bridge and replacing it with either a steel pipeor concrete culvert

Bridge Repair contract: Bridges #36 (CR25N over Eagle Creek),#38 (CR 25 N over Eagle Creek),#52 (CR 850 S over Osborn Ditch),#66 (Range Rd. over Smith Ditch, just south of 500S), and #137 (CR 300 E over Yellow River)

BRIDGE INSPECTIONS – Phase I of our latest round of bridge inspections is complete. The draft of the "Bridge book" has been submitted by USI Consultants, our bridge inspectors. We are happy with the results. They have produced a condensed, easy to use inspection report that shows that the condition of our bridges has significantly improved over the last two years. Our number of deficient bridges has decreased from 17 to 12 and by the end of the year this number should be 10. Our goal of no deficient bridges in the County is on schedule for a 2020 completion date. Our number of posted bridges (rated for 15 tons or less) has decreased from 16 to 12 and could be as low as 9 by the end of the year. We also had 5 bridges that were not rated for school buses, now we only have two #96 (900S, .5 miles west of US421) and #36 (.1 miles w of CR600E). By the end of the year that number should be zero. Two years ago we had one bridge closed. That bridge has been replaced and now no bridges are closed in Starke County.
