BRINE USE

The last couple of days are a good indication of how salt brine applied to roadways before a storm can dramatically improve pavement conditions on a roadway during and after a snowfall. INDOT heavily pretreated their roads with brine last Friday. Their roads were clear and “wet” almost immediately after the snow stopped falling each day. In contrast our roads, despite our best efforts, are not clear and “wet”. We are still transitioning to where we can have a complete brine program. This will allow us to eliminate most of our sand use. Our goal is to have the brine program up and running this summer as we can also use the brine for dust control. Here are the steps we are taking to do this:

- 1) Installing a brine machine
- 2) Add a second sprayer truck
- 3) Meeting with an experienced INDOT maintenance supervisor who has over ten years of experience making INDOT facilities brine capable
- 4) Adding storage areas
- 5) Add a truck wash bay
- 6) Attend facility upgrade lecture at Road School

ROADWAY MANAGEMENT

- 1) 300E project (May 14, 2018)
- 2) Road improvement list (Hot Mix, Cold Mix, Chip Seal, Cold in plant recycling, and re-gravel)
- 3) Traffic counts
- 4) PASER ratings
- 5) Material 15000 tons of #11 stone are needed for the chip sealing and pug paving we are doing this summer. We currently have about 6500 tons in the yard.
- 6) Meeting this month with vendors to set up pilot projects involving both our cold mix asphalt (pug) paving and rejuvenating seals
- 7) Mowing/brush cutting. At the Farm Bureau policy meeting last week, they expressed their happiness with our enhanced R/W clearing.
- 8) Patching

Bridge Inspections

- 1) Phase IIA of our current bridge inspection cycle is complete.
 - a) Only nine bridges on the list. Three were replaced last year, four are being replaced this year, and the last two we specifically asked to be put on the 12-month cycle
 - b) The last invoice for this cycle of bridge inspections is being paid this month to USI
- 2) We are meeting with our new bridge inspection consultant, United Consultants, on January 12th to discuss contract terms.

CULVERTS AND DRAINAGE

Culvert Inventory – Our construction inspector is inspecting all of our culverts this spring. While he is doing this, he is using GPS to add each pipe's exact location into our County's GIS system

HIGHWAY FUNDING

On March 3, 2018 the Superintendent is going to speak at the Bass Lake Property Owners Association monthly meeting. They expressed a desire to see how the County is planning on using the additional funding made possible by last year's highway funding bill. He will show them a power point presentation that outlines the Department based on the asset management principles instituted in 2013. It will also show what the state of our roads and bridges were five years ago, what they are now, and what they will be ten years from now based on the current improvement and maintenance programs in each asset management category. On March 5th he will give that same presentation to the Board of Commissioners at their meeting.
