We just received notification that the State salt bid amounts for 2018 can now be submitted. We submitted next year's bid this afternoon. We are committed to ordering at least 80% of our bid amounts and no more than 120%. Because of the low usage this year we are expecting the 2018 price to be below the current 56.18 for untreated salt and \$78.34 for the treated salt. We are hoping to stockpile a year's worth of salt at next year's lower prices.

Heavy Truck Ordinance

The Heavy truck ordinance committee met on March 2nd to review the initial draft and discuss possible changes or additions. The two primary functions of the ordinance will be to outline a system of hot mix truck routes and to provide a reasonable method of enforcement of weight and route limits. The committee will review and possibly amend the designated routes before the final draft is presented to the Commissioners on April 4th. After the committee has a chance to submit their recommendations County Attorney Lucas and the Highway Superintendent will work together to create the final draft.

PASER ratings – In January Purdue LTAP published their "Indiana 2016 Local Road and Bridge Conditions Report" It reported that the 44% of all Indiana roads were rated poor, 45% were fair, and 11% were rated good. Starke County roads fared somewhat better at 14% poor, 70% fair, and 16% good. It is the goal of our 15-year road improvement plan to both eliminate all the poor roads and increase the number of hot mix roads in the County from 13 miles to over 75 miles, thus allowing the establishment of truck routes that will help preserve all our County roads.

We recommend awarding the design to JPR of Mishawaka. Because of their very low bid we asked them to also give us an estimate on our last deficient bridge where development has not begun, Bridge 154 on 100E, north of 400N. The design estimate for that bridge was \$25,000. We recommend having JPR do that bridge as well because the total cost for the three bridges will still be lower than the other bids were for two.

FACILITIES

Roof Repairs and Resealing

As weather permits the roofing contractors will be replacing the roof over the office area and resealing the garage area roof. The money for these repairs was allocated last year from monies received from permits, scrap, insurance reimbursements, etc..

FUNDING REPORT

HB 1002 – The Superintendent, along with Commissioner Chesak and Bob Troike of the Farm Bureau travelled to Indianapolis in February to lobby for Local Road funding. We spoke with all four of our local representatives to the State House and Senate (Jim Pressell, Mike Bohacek, Ed Charboneau, and Bob Gutwein). We emphasized to them the importance that funding from the bill trickle down as much as possible to the local without much State interference. We were told that most of the funding will be available to the locals in the form of matching funds, most likely an 80/20 match. If so, it is important that the County makes sure that matching funds for roadways are available each year. Otherwise, other Counties and Cities that have ways to match those funds will benefit from Starke County tax dollars at the expense of Starke County roads.
