Starke County Highway Department Monthly Report – October 2Nd, 2017

COMMUNITY CROSSINGS GRANT

On September 19^{th,} the County was notified by INDOT that we received three Community Crossings Grant awards in the amount of \$570,832.13. Two of these projects are already complete and we will be using the funds we are reimbursed for those to complete the projects that are being awarded tonight. Also, Starke County Economic Development Foundation will be providing the matching funds for the 300E paving. This means that the County is not "on the hook" for any matching funds. This provides a great deal of flexibility moving forward with additional projects in the future. It also allows us to competitively compete for additional funds during INDOT's call for Federally funded rural projects which begins on October 9th and has a November 22, 2017 deadline. In the last year we have received \$1,687,524.42 in State grant money:

\$1,080,000.00 in State funds for Bridge #7

\$570,832.13 in Community Crossings Grants

\$36,692.29 for the Railroad crossing marker and sign grant.

We are looking at a few potential projects to include with our Federal Rural call for project applications.

- 1) The Bass lake intersection improvement at CR210 and old SR10, which will include plans for a bike trail station that would be coordinated with the local trails group.
- 2) The 600E extension from SR8 to CR25N
- 3) Four hot mix truck route projects (Possibly CR1100E, 700E, Range Road, and CR400S)

In all we have the possibility of receiving well over \$2,000,000.00 in grant money this year. This will give us a great start to recently establish Roadway Asset Management plan.

2018-2021 BRIDGE INSPECTION PROJECT

We are currently completing our 2013-2017 round of bridge inspections. USI of Indianapolis is our consultant for this round. In conjunction with INDOT we have just sent out the RFP (Request for proposals) for our next round of inspections. We have made it our policy to seriously consider changing our inspection consultant each time because we believe that a "fresh" set of eyes is important. We are meeting with five bridge consultants next week, and probably more after that. We are expecting up to 7 or 8 companies to submit a LOI (letter of interest) for this RFP.

CULVERT MAINTENANCE

When we inspected our culverts earlier this year we identified 59 that could possibly be replaced. We have replaced 40 pipes thus far, with 3 to go. 16 were deemed either to have a few years of service life yet or were not a danger to the roadway and/or did not impede drainage. These 16 pipes will be reassessed next year.

ROADWAY SAFETY

As you drive throughout Starke County you may begin seeing a new traffic control device designed to increase visibility and overall safety at intersections. We are installing reflective strips on our sign posts. For the cost of less than \$25.00 an intersection we are greatly increasing stop sign visibility. Transportation safety studies have shown this simple measure can reduce the number of intersection accidents as much as 5% to 15% per year.



INFLUENTIAL WOMEN OF NORTHWEST INDIANA AWARD

Last Thursday was a big night for one of our employees! Rachel Oesterreich, our office manager, won the 2017 most Influential Woman of Northwest Indiana award in the category of Economic Development and Government. WINTER PREPARATIONS

This month we received notification of our salt prices for this year. The good news is that the price decreased by almost \$5.00 a ton from 56.18 to 51.39 a ton for untreated bulk road salt. The treated salt price remained basically the same, this year's price is \$72.32 a ton, whereas last year's price was \$72.84.
