Starke County Highway Department Monthly Report – October 3, 2016

CURRENT BRIDGE REPLACEMENT PROJECTS

County Bridge #78 (250W, .5 mlles S of Toto Rd.) Construction was scheduled to begin today but will begin next week due to contractor delays.

County Bridge #96 (900S, .5 miles w of US421) This bridge was replaced with three CMP pipes last month.



County Bridge #50 (CR1150E, .9 miles SR10.) This bridge was awarded to Norther Indiana Construction last month. The selected bid was \$270,531.00. This was almost \$46,000 less than the engineer's estimate.

County Bridge #46 (CR900E, .8 miles SR10) The design for this bridge is almost complete. It will be advertised for a November 7th, 2016 bid opening. The bid will be for the replacement of both bridge 46 and 47. They will be closed simultaneously to allow the contractor to minimize mobilization costs. We believe this will result in significant savings for the County. Construction is slated to begin on April 1, 2017

County Bridge #47 (CR625S, just west of 875E) The design for this bridge is almost complete. It will be advertised for a November 7th, 2016 bld opening. The bid will be for the replacement of both bridge 46 and 47. They will be closed simultaneously to allow the contractor to minimize mobilization costs. We believe this will result in significant savings for the County. Construction is slated to begin on April 1, 2017

County Bridge #7 (1200E, 1.1 miles S of SR8) Today Starke County was awarded \$1,080,000.00 in matching funds for this bridge replacement in 2019. It represents an 80% match for the entire cost of the project. The County pays a 20% match. The Community Crossings match is 50/50 which means that the County gets a much better bang for its buck with this project. We still plan on using Community Crossings matching funds for our two bridges (46 and 47) which will be awarded in November and constructed next year and matching those funds with funds from our recent LOIT distribution. What this means that instead of using all the LOIT funds to match Community Crossings funds as many cities and towns did we decided to concentrate on the project that awarded much more in relation to what the County has to provide. That does not mean we will completely neglect the use of CC matching funds. We will match at least \$250,000, possibly up to \$500,000. Only about half of that will be from the LOIT distribution. The rest will come form money that is currently budgeted for bridges. No new taxes or additional funding appropriations will be needed. It will all be matched from existing funding. This means that we were able to use the remaining \$250,000.00 on road improvements. To summarize, instead of receiving \$500,000 in matching funds at a 50(state)/50(county) rate, Starke County will be receiving at least \$1,330,000.00 in matching funds with a rate of 65(state)/35(county) AND have \$250,000 extra LOIT funds that we were able to put directly into road improvements. Most local agencies had to choose between either ten to 20 miles of road improvements or one, maybe two bridge improvements. We will be able to replace five bridges (one a larger Yellow River bridge) and complete fifteen miles of road improvements

CURRENT ROAD IMPROVEMENTS

As of last week, we have completed all three planned rounds of paving and chip

sealing this year. We were also able to add miles of improvements during those rounds thanks to the extra LOIT funds. We still have one tanker of chip seal oil left that we plan on using during the next few weeks if the weather holds. If so, we will have completed of fifty miles of improvements while at the same time replacing four deficient bridges this year. We will also be make three tankers worth of asphalt patch for our use during the winter. Below is a picture of the road improvement completed on 600E between SR10 and 800S south of Bass Lake where we chip sealed over a road we wedged last year. This technique worked well and saved money for the County. Other examples are 500S between US35 and 100E and 800S between 300E and 450E.

WINTER PREPARATIONS

SALT BID Last year we paid \$65.92 for untreated salt, this year we will be paying \$56.16 per ton. We have committed to 1250 tons of salt for the winter. We will also be experimenting with a small amount (100 tons at \$72.84 a ton) of treated salt. Untreated salt works to about 15degrees F. Treated salt can work to about -5 degrees F. When the temperature drops below 10 degrees this winter we will start using treated salt to see if it is something we may want to use in the future.

Dear Mr. Ritzler,

Congratulations! Your community has been awarded \$1,080,000.00 in Federal Highway Administration (FHWA) construction funds for the Bridge#7 project. INDOT will be awarding funding for the other phases of your project at a later date. With these funds, you join Governor Mike Pence and the Indiana Department of Transportation (INDOT) as we build and improve Indiana's infrastructure. Please understand that award amounts (not Grants) are contingent upon funding availability through Congressional Appropriations.

The FHWA funds, which are administered by INDOT, may be used for funding up to 80% of any phase of your project. This reimbursement funding cannot exceed 80% of the total project cost. You will be required to submit paid bills before reimbursement. In addition, you will be required to submit 20% of total construction costs before the Notice to Proceed for construction will be issued. If your project is being funded with Safety Funds, they will be reimbursed at a different rate than the normal 80/20%. Please be aware that INDOT no longer allows development credits for any project. The awarded amount is the Approved Project Allocation for the project so please keep your project's original scope within its budget.

You will be assigned an INDOT LPA Project Manager who will be required to maintain a schedule to demonstrate your willingness to complete your project in a timely manner or the funding for your project may be withdrawn. The steps to start your project are as follows:

- 1. Designation Number (1600940) has been assigned by the district to your project.
- 2. You need to contact your District Program Director to schedule an Early Coordination Meeting within 30 days of receipt of this letter. {Marcia Blansett} is your contact and can be reached at 219/325-7564.
- You are required to send quarterly reports to the district reporting progress on the development of your project.

Please note that work done, in any phase, without prior FHWA approval is not eligible for reimbursement. The process for obtaining this approval will be discussed at the early coordination meeting. Furthermore, any increase in project cost above the apportionment amount must be paid for locally.
