

PRIMARY (MUNICIPAL) ELECTION MAY 7, 2019 CALENDAR

WEDNESDAY, JANUARY 09, 2019: First day that a major political party candidate may file a declaration of candidacy for the municipal primary.

First day to file a declaration of candidacy for nomination by a town convention in a town having a population of less than 3,500.

First day an independent or a minor party candidate may file a petition of nomination for the municipal election. 91 signatures will be needed and approved by Voter Registration in the Clerk's office.

First day to file a declaration of intent to be a write-in candidate at the municipal election.

WEDNESDAY, JANUARY 16, 2019: DEADLINE, by noon, for all candidate committees, legislative caucus committees, and political action committees to file annual campaign finance reports for 2018.

FRIDAY, FEBRUARY 8, 2019: DEADLINE, by noon, to file a declaration of candidacy for the municipal election.

MONDAY, FEBRUARY 11, 2019: DEADLINE, by noon, to file a withdrawal of candidacy for the primary election.

SATURDAY, MARCH 23, 2019: the county election board will start mailing primary election absentee ballots to voters who have previously filed an approved 2019 primary election application with the circuit court Clerk. An applicant can summit an application in person, mail, faxed or email to the starke county election, in the clerk's office. If an applicant is in need of an application please contact voter registration. You can also print out an absentee ballot application online through www.in.gov/sos/elections/2402.htm and mail, fax or hand deliver to the county election, in the clerk's office. Absentee Applications will be accepted until Monday, April 29, 2019 by 11:59 pm.

MONDAY, APRIL 8, 2019: VOTER REGISTRATION ENDS for a voter to register or transfer registration or at midnight for a voter to complete and submit a voter application online at <u>www.indianavoters. in.gov</u>

TUESDAY, APRIL 9, 2019: First day a voter may vote absentee in the Starke County Court House.

HOURS: MONDAY-FRIDAY 8:00 AM to NOON and 1:00 pm to 4:00pm

ADDITIONAL HOURS: will be posted for evening and Saturday hours in April.

THURSDAY, APRIL 18, 2019: First day a confined voter, a voter caring for a confined person at a private residence, or a voter with disabilities may vote an absentee ballot before an absentee voter board at the voter's residence or place of confinement.

MONDAY, APRIL 29, 2019: DEADLINE, by 11:59 pm, for the county election, in the clerk's office to receive an absentee ballot application from an applicant requesting delivery of an absentee ballot <u>by</u> <u>mail.</u> Applications may be submitted to the county election in person or by mail, fax, or email. Deadline does not apply to voters entitled to vote by traveling board.

MONDAY, MAY 6, 2019: DEADLINE, by noon. For county election, in the clerk's office to receive absentee ballot applications from confined person or voters caring for the confined requesting delivery of a ballot by an absentee voter board.

DEADLINE: by noon, for county election, in the clerk's office to receive absentee ballot applications from military/ overseas voters requesting vote by email or fax.

DEADLINE: by noon, for a voter to vote an absentee ballot in person on the first floor in the Starke County Court House.

DEADLINE: for a confined voter, a voter caring for a confined person, or a voter with disabilities to vote an absentee voter board at the voter's place of confinement.
