

**A RESOLUTION PROVIDING FOR THE REDUCTION
OF APPROPRIATED EXPENDITURES FROM
THE STARKE COUNTY CUMULATIVE CAPITAL DEVELOPMENT
FUND**

Resolution No. ⁰⁰⁵ ___ of 2022

WHEREAS, the County Council of Starke County, Indiana (the “**Council**”), is responsible for the performance of various functions for the Starke County, Indiana (the “**County**”); and

WHEREAS, the Council has previously appropriated the sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) for expenditures from the County’s Cumulative Capital Development Fund, Fund #1138 (the “**Fund**”) for the fiscal year, January 1, 2022, through December 31, 2022; and

WHEREAS, in the interests of fiscal responsibility, the Council has determined that it is in the best interests of the health, safety and welfare of the County’s citizens, and the health and fiscal vitality of the County, that the appropriated amount for expenditure from the fund for the current fiscal year be reduced to Seventy Thousand Dollars (\$70,000.00); and

NOW, THEREFORE, BE IT ORDAINED by the County Council of Starke County, Indiana, that this Resolution Providing for the Reduction of Appropriated Expenditures from the Starke County Cumulative Capital Development Fund, is hereby adopted as follows:

Section I.
Reduction

1. **Reduction in Appropriated Fund.** Fund # 1138, the County Cumulative Capital Development Fund is hereby reduced by a sum of One Hundred and Eighty Thousand Dollars (\$180,000.00). The new, appropriated amount available for County expenditure shall be Seventy Thousand Dollars (\$70,000.00) for the fiscal year, ending December 31, 2022.

Section II.
Effective Date


1. This Ordinance shall become effective immediately upon its passage by the Starke County Council, and as of the date set forth, below.


