

**AN ORDINANCE ESTABLISHING THE USE OF RECORDER'S
RECORDS PERPETUATION FUND DURING CALENDAR YEAR 2023

Ordinance No. 16 of 2022

WHEREAS, MANDY THOMASON, Recorder of Starke County (the "Recorder") has requested that the sum of \$500.00 of the Recorder's Records Perpetuation Fund be used to pay for postage expenses of the Recorder's office for calendar year 2023 pursuant to authority and conditions of Ind. Code § 36-2-7-10.2(b); and,

WHEREAS, the Recorder has filed an affidavit in support as required by said statute, which affidavit is attached hereto as Exhibit A; and,

WHEREAS, the Council finds that the Recorder's affidavit is in proper form and complies with the statute and finds that the Recorder's request should be and hereby is approved and adopted.

NOW, THEREFORE, BE IT RESOLVED, by the Starke County Council, Starke County, Indiana, that:


The request of the Recorder to use the sum of \$500.00 of the Recorder's Records Perpetuation Fund to pay for postage expenses of the Recorder's office for calendar year 2022 is hereby GRANTED. This ordinance is valid for calendar year 2023 only.
