

**AN ORDINANCE ESTABLISHING THE USE OF RECORDER'S
RECORDS PERPETUATION FUND AND MILEAGE DURING CALENDAR YEAR
2024 FOR STARKE COUNTY, INDIANA**

Ordinance No. 003 of 2023

WHEREAS, MANDY THOMASON, Recorder of Starke County (the “Recorder”) has requested that the sum of Five Hundred and Fifty Dollars (\$550.00) of the Recorder’s Records Perpetuation Fund be used to pay for postage expenses of the Recorder’s office for calendar year 2024 pursuant to authority and conditions of Ind. Code § 36-2-7-10.2(b); and,

WHEREAS, the Recorder has requested that the sum of Four Hundred Dollars (\$400.00) of the Recorder’s Records Perpetuation Fund be used to pay for approved mileage expenses for the Recorder’s office for calendar year 2024; and

WHEREAS, the Recorder has filed an affidavit in support as required by said statute, which affidavit is attached hereto as Exhibit A; and,

WHEREAS, the Council finds that the Recorder’s affidavit is in proper form and complies with the statute and finds that the Recorder’s request should be and hereby is approved and adopted.

NOW, THEREFORE, BE IT RESOLVED, by the Starke County Council, Starke County, Indiana, that:

The request of the Recorder to use the sum of Five Hundred and Fifty Dollars (\$550.00) of the Recorder’s Records Perpetuation Fund to pay for postage expenses of the Recorder’s office for calendar year 2024 is hereby GRANTED. This ordinance is valid for the calendar year 2024 only.

The request of the Recorder to use the sum of Four Hundred Dollars (\$400.00) of the Recorder’s Records Perpetuation Fund to pay for mileage expenses of the Recorder’s office for calendar year 2024 is hereby GRANTED. This ordinance is valid for the calendar year 2024 only.




