Household Hazardous Waste are unwanted products that contain corrosive, toxic, ignitable, or reactive ingredients that require special care upon disposal. The district sponsors the collection event so that Starke County residents can safely dispose of these materials.

ACCEPTABLE HAZARDOUS WASTE:

Oil/ Oil Filters
Batteries-Household/Batteries,
rechargeable/lead- acid
Mercury/ Thermometers/ Thermostats
Pet spray and dip/ Flea collars
Poisons
Pesticides/Herbicides / Fungicides/ Insecticides
Chemicals/ Ammonia
Oil Based Paints/ Solvents/ Thinners

Cleaners
Insecticide and insect repellent
Waste Fuels/ Old Gasoline/ Antifreeze
Fluorescent Tubes/ CFL's
Aerosols
*Medications/Sharps
Pool Supplies
Adhesives and glues/ Unknowns

HOUSEHOLD HAZARDOUS WASTE ACCEPTED FROM RESIDENTIAL HOUSEHOLDS IN UNLIMITED QUANTITIES MUST BE HOUSEHOLD ONLY AND NOT INCLUDE COMMERCIAL OR INDUSTRIAL WASTE.

SMALL BUSINESS CESQU/FARMS- HAZARDOUS WASTE LIMIT OF 100 POUNDS.

NO LATEX PAINT; LATEX PAINT IS NOT ACCEPTED AS IT'S NOT A HAZARDOUS WASTE. TO DISPOSE OF LATEX PAINTS, ALLOW THE PAINT TO DRY OUT; EITHER BY REMOVING THE LID OR ADD KITTY LITTER; ONCE DRY PAINT CAN BE DISPOSED OF THROUGH YOUR WASTE HAULER.

**NOT ACCEPTED AT THE EVENT: NO TIRES, NO RESIDENTIAL GARBAGE,
NO FURNITURE, NO CONSTRUCTION DEBRIS
